The Project includes the following Work:

1. Existing M-71 Water Booster Pump Station - Replace pumps, electrical equipment, and appurtenances, re-shingle roof, standby generator, site work including access drive, fence, and appurtenances.
2. Proposed Parmenter Rd. Water Booster Pump Station – Construct packaged water booster pump station, standby generator, and appurtenant site work.
3. Proposed M-21 water Booster Pump Station – Construct packaged water booster pump station, standby generator, and appurtenant site work.
4. Parmenter Rd. and E. McNeil St./Dutcher Rd. PRVs – Construct/install pressure reducing valves.
