Sealed Bids for the construction of the Project will be received at the Office of City Clerk at Corunna City Hall, 402 N. Shiawassee St., Corunna, MI 48817, until Tuesday, June 25, 2024 at 3:00 p.m. local time. At that time, the Bids received will be publicly opened and read aloud.

The Project includes the following Work:

1. W. McNeil St. – S. Norton St. to S. Shiawassee St., approximately 1,475 ft. – Replace water main, replace and construct sanitary sewer.
2. E. McNeil St. – S. Comstock St. to Parmenter Rd., approximately 775 ft. – Construct water main, sanitary sewer extension, sidewalk, and ramps.
3. N. Comstock St. – E. McArthur St. to E. Corunna Ave., approximately 350 ft. – Replace water main, remove/replace sidewalk, replace ramps.
4. W. State St. – Norton St. to Shiawassee St., approximately 1,375 ft. – Replace water main and sidewalk ramps.
5. Northwest Transmission Loop – Oak St. to Sleseman Dr., approximately 2,950 ft. – Construct water main, replace sidewalk ramps.
6. Parmenter Industrial Park Access Rd., approximately 900 ft. – Construct water main, sanitary sewer, and gravel access road.
7. W. Mack St. – N. Norton St. to N. Bachus St., approximately 700 ft. – Replace water main, construct sanitary sewer, reconstruct road, replace sidewalk ramps.
8. W. McArthur St. – N. Norton St. to N. Woodworth St., approximately 1,075 ft. – Replace water main, reconstruct road, replace sidewalk ramps.
9. E. Oliver St. – S. McDonnell St. to Kingsley St., approximately 1,650 ft. – Replace water main, reconstruct portion of road, replace sidewalk ramps.
10. Kingsley St. – E. Oliver St. to E. McArthur St., approximately 650 ft. – Replace water main, reconstruct road.
11. N. Shiawassee St. – Oak St. to Pine St. – Connect water services to 12" water main; at Cherry St. connect 6" water main to 12" water main.
12. N. Shiawassee St. – Ferry St. to Oak St., approximately 400 ft. – Replace water main, reconstruct road.

13. N. Shiawassee St. - Shiawassee St. Bridge to Pine St., approximately 2,150 ft. – Mill/resurface, construct HMA widening, construct storm sewer, remove/replace sidewalk, and ramps.
14. Ferry St. – Charles St. to N. Shiawassee St., approximately 700 ft. – Replace water main and storm sewer, repair sanitary sewer, reconstruct road, replace sidewalk ramps.
15. Water Service Line Investigation and Replacement.
